Literacy Policy

Literacy Policy

1. Aim

To ensure the highest standards of literacy, vocabulary, oracy and the correct use of Standard English

2. Objectives

2.1 To ensure that our pupils foster a love for reading and read frequently

2.2 To ensure that all teachers, in all subjects, and in all lessons, actively develop the literacy skills of our pupils

3. Guidelines

3.1 All pupils in year 6 will receive a book to read during the transition period and over the summer break which will be studied and linked with KS3 learning objectives through a travel writing transition unit during the autumn term of Year 7

3.2 All pupils in Year 7 will complete a spelling age test on entry and they will complete a baseline writing and reading assessment linked to the transition novel. Pupils with a reading age below 10 years will receive additional support during library lessons. Such pupils will also receive intensive vocabulary support.

3.3 To promote reading for pleasure, pupils will read during at least one single tutor period during the course of the week. All English lessons in Years 7-9 will begin with a short period of silent reading. Pupils will complete a literacy activity in tutor time once per fortnight. It is the responsibility of Tutors and the subject leader of English to ensure this takes place

3.4 At least once per fortnight each English class will attend a library lesson where they will read in silence, exchange their accelerated reader book or take an online test. The English teacher and HLTA responsible for Accelerated Reader will track progress of all pupils' reading age and monitor engagement of reading. The English teacher responsible for the class will monitor individual pupil's current attainment and progress and intervene when necessary through a review process in the library lesson. Rewards will be given to those pupils demonstrating exceptional effort and progress towards their target

3.5 Pupils in Year 7 and 8 will receive a SPAG lesson as part of the English curriculum to promote accuracy and ambition.

3.6 Pupils in years 7 and 8 engage in Bedrock Vocabulary weekly during English lessons and at home. Pupils are expected to complete two 'lessons' per week. This is monitored and reviewed by their English teacher and recorded in pupils' planners.

3.7 The following codes must be used to draw attention to aspects of literacy:

- P = Punctuation mistake
- c/s = Comma splice mistake
- s = Spelling mistake
- CL = A capital letter is missing
- // = New paragraph needed
- G = Grammar mistake
- T = Tenses mistake
- V = Vocabulary

All pupils in the school will have these codes stuck on the front of their books at the start of the academic year

3.8 English and Modern Foreign Languages teachers will continue to teach their subjects using their established strategies, but may choose to apply some aspects of the literacy policy

4. Expectations

4.1 Teachers are expected to:

- 4.1.1 Demonstrate consistently high standards of literacy and use of ambitious vocabulary
- 4.1.2 Provide opportunities for pupils to read, talk, listen and write
- 4.1.3 Explicitly state what aspect of literacy is being developed in each lesson
- 4.1.4 Highlight no more than five literacy errors for any one pupil. Errors will be highlighted using the codes from the Literacy Mark Scheme. Where an error is identified the teacher will write the correct code in the margin adjacent.

4.2 Pupils are expected to:

- 4.2.1 Correct any literacy errors in green pen
- 4.2.2 Routinely visit the school library to exchange their reading books
- 4.2.3 In KS3 routinely visit the library and exchange their accelerated reader book and take the appropriate on-line test.
- 4.2.4 Attend their Tutor period and English lessons with their reading book
- 4.2.5 Complete reading homework for one hour per fortnight in line with the KS3 English curriculum

4.3 Parents are expected to:

- 4.3.1 Encourage pupils to read and use Bedrock vocabulary
- 4.3.2 Try and provide a quiet place where pupils can read and encourage them to use the school library
- 4.3.3 Routinely use the Accelerated Reader website to monitor the books their child has read and the progress they are making

4.4 Middle leaders are expected to:

- 4.4.1 Ensure that pupils are reading in silence during at least one single tutor period during the course of the week.

4.5 The Leadership Team are expected to:

- 4.5.1 Ensure that the whole school literacy policy is fully implemented
- 4.5.2 Evaluate the impact of this policy on the quality of literacy skills
